COMMUNITY ENGAGEMENT

Earlier this year, Granite Hills Wind Farm engaged in community and stakeholder consultations, including both Bega Valley Shire Council and Snowy Monaro Regional Council. Some of the topics the community raised at that time included traffic management, fire risk, possible fauna and noise impacts and visual amenity. These topics, along with many others, are being considered during the preparation of the Environmental Impact Statement, which is guided by regulations from both the NSW state Department of Environment and the federal Department of Energy and Environment. If you have any ideas on ways the wind farm could positively enhance the local community, please let us know.

WE ARE LISTENING - MEET OPF!

Following feedback from the CCC and other stakeholders, Granite Hills Wind Farm has appointed OPF Consulting (OPF) to conduct the ongoing community consultation role for this project. Their team has long term experience in community liaison and with clean energy projects – from initial concepts through the approval, design, construction and operational phases. OPF helps to facilitate open and transparent engagement through traditional and digital communication channels and IAP2 consultation methodologies. Elizabeth Picker and Diana Forrester will be meeting residents, community groups and other stakeholders in late November and early December and ongoing.

STAKEHOLDER AND COMMUNITY ENGAGEMENT PLAN

The Stakeholder and Community Engagement Plan has been released. This plan outlines the activities and tools we will use to consult key stakeholders and the community during all phases of the Granite Hills Wind Farm project – from development through construction, operation and final decommissioning. It includes stakeholder mapping, objectives, guiding principles and methods of engagement. An early draft version of the plan was circulated to the CCC in September. The finalised plan is now available on our website, where it can be read online or downloaded. Hard copies of the plan will be provided to both Councils and the Community Consultative Committee.

ABOUT THE PROJECT

Granite Hills Wind Farm is a State Significant
Development, situated in
Steeple Flat, approximately
12 kilometres South East of
Nimmitabel in New South
Wales. When complete the
project will comprise of up
to 32-wind turbines, with
approximately 3-5 megawatts
capacity and a maximum
tip height of 200 metres.
The 132MW wind farm would
generate enough clean
energy for around 50,000
homes.

COMMUNITY CONSULTATIVE COMMITTEE

Community Consultative Committees (CCC) play an important role in ensuring proponents engage with the community and stakeholder groups on State Significant Developments. The list of members is available on our website.

CCC meetings ensure the community and stakeholder groups are kept informed of the status of the project, consulted on the development of the project, plans and any proposed changes. Members are also able to provide feedback on issues that may arise during the development of the project.

The last CCC meeting was held on Tuesday 11th of September 2018. Minutes of all CCC meetings can be found on the project website. Every meeting is chaired by an Independent Chair, Peter Gordon. PROJECT UPDATE

We continue to work on the Environmental Impact Statement. Additional bird monitoring is currently underway to increase our understanding of birds in the area so we can avoid impact.

In accordance with the Office of Environment and Heritage Aboriginal Cultural Heritage consultation requirements for proponents (2010), indigenous Australians and Registered Indigenous Parties were consulted by an independent specialist during heritage surveys of the project area. The independent specialist determined Bega Local Aboriginal Land Council to be most connected to the project site. The specialist has been contracted to provide strategies for ensuring any indigenous heritage found on site is protected and maintained. All registered parties have been asked to provide comment on the draft archaeological report.
